	<p>measures include computer safeguards and secured files and buildings.</p> <p>All information collected is stored in a technically and physically secure environment. We store and transmit information with SSL encryption software.</p>
<p>How does SimpliFast Lending, LLC collect my personal information?</p>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ● Apply for a loan ● Give us your income information ● Provide employment information ● Provide account information ● Give us your contact information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<p>Why can't I limit all sharing?</p>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ● Sharing for affiliates' everyday business purposes – information about your creditworthiness ● Affiliates from using your information to market to you ● Sharing for nonaffiliates to market to you
<p>What happens when I limit sharing for an account I hold jointly with someone else?</p>	<p>Your choices will apply to everyone on your account.</p>

Definitions	
<p>Affiliates</p>	<p>Financial and nonfinancial companies related by common ownership or control.</p> <ul style="list-style-type: none"> ● <i>SimpliFast Lending, LLC has no affiliates</i>
<p>Nonaffiliates</p>	<p>Financial and nonfinancial companies not related by common ownership or control.</p> <ul style="list-style-type: none"> ● <i>Nonaffiliates we share with can include service providers, direct mail, data processors and advertisers.</i>
<p>Joint Marketing</p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ● <i>Our joint marketing partners include financial institutions, credit card companies, partners that promote our products, pre-paid debit card providers and other lending companies.</i>
